

Transport

The PNVF x Nuvali Sand Courts is about a 5-minute walk from the hotel, passing along a scenic lake. All the same, Seda Nuvali offers free shuttle service to go around the Nuvali and Solenad locators.

Microtel by Wyndham South Forbes is a bit farther off, which would take 10 minutes or less by vehicle. The hotel also offers free shuttle service to go around the Nuvali and Solenad locators., but the LOC will ensure to add a timed shuttle service for qualification teams.

Medical Services and Procedures

During Competition & Training

- During competition & training, first responders with an ambulance will be on standby at the venue.

Out of Competition & Training

- While out of competition & training, first aid treatment will be possible at the hotel. If more treatment is necessary, the Local Organiser will provide transport to an external facility (if required).
- The choice of hospital will be determined based on the severity of the injury.

Playing tops/tanks will be provided to all athletes (Main Draw and Qualification) by the Local Organiser. Shorts/bottoms and accessories are the responsibility of the players and/or their sponsors. If required by the FIVB Technical Delegate, other uniforms and accessories will be checked during the Preliminary Inquiry. Athletes of the same team must wear the same colour and style of shorts.


