



# AVC Qualification System To the 2022 FIVB Beach Volleyball World Championships

# 1. Max Total Quota from AVC Qualification Pathway

- Men: 4 teams (8 athletes)

- Women: 4 teams (8 athletes)

#### 2. Type of allocation of Quota places

The quota place is allocated to the National Federation (NF). Each NF must choose its athletes respecting the criteria set forth in 3. Athletes Eligibility.

#### 3. Athlete Eligibility

All athletes must comply with the criteria set forth in 2022 FIVB Beach Volleyball World Championships Qualification System document circulated on 28<sup>th</sup> February 2022.

Additional AVC Eligibility Criteria:

To be eligible to represent a NF that has been allocated a quota place through the AVC qualification pathway to the 2022 FIVB Beach Volleyball World Championships, all athletes must have participated as an individual minimum in one (1) AVC beach tour event or Asian Beach Volleyball Championships scheduled between 1<sup>st</sup> July 2019 to 23<sup>rd</sup> May 2022.

#### 4. Qualification Pathway

- 4.1 AVC Qualification period will be from 1<sup>st</sup> July 2019 to 23<sup>rd</sup> May 2022. All AVC homologated tournaments will be included in the AVC Qualification process, as
  - below:
    - 2019 AVC Beach Tour Penghu Open
    - AVC Continental Cup 2019-2021 edition (all phases completed during the period of 1<sup>st</sup> July 2019 to 30<sup>th</sup> June 2021)
    - 2020 Asian Beach Volleyball Championships in Udon Thani, Thailand
    - 2021 Asian Beach Volleyball Championships in Phuket, Thailand

In addition to the above-mentioned AVC homologated tournaments, maximum one finish at FIVB World Tour events (1-5 star as well as 2019 World Tour Finals) or Volleyball World Beach Pro Tour (Elite16/Challenge/Futures) or homologated multi-sports event held within the above-mentioned date window specified in 4.1 will be counted if such result improves the ranking of the NF concerned.

- 4.2 AVC Beach Tour National Federation Ranking established between 1<sup>st</sup> Jul 2019 to 23<sup>rd</sup> May 2022 will be used to qualify the quota places for the 2022 FIVB Beach Volleyball World Championships.
- 4.3 The four (4) highest ranks per gender as per the above AVC Beach Volleyball National Federation Ranking will qualify to the 2022 FIVB Beach Volleyball World Championships, respecting the maximum number of quota places per NF per gender and the provisions

established in the 2022 FIVB Beach Volleyball World Championships Qualification System document circulated on 28<sup>th</sup> February 2022.

- 4.4 The calculation of AVC Beach Volleyball National Federation Ranking are as follows:
  - The top four (4) results from tournaments above-mentioned in 4.1, will be counted towards the calculation of the AVC National Federation Ranking.
  - AVC ranking points of the best two (2) teams from each NF per gender from each of tournaments above-mentioned in 4.1, will be counted towards the calculation of the AVC Beach Tour National Federation Ranking.
  - The ranking points earned with the best result will be labelled as NF 1 finish and second-best result will be labelled as NF 2 finish.
  - The sum of all NF 1 finishes in all events the NF concerned participated will be the final ranking points of NF 1, regardless of the different players' composition of the team in each tournament, but not including result obtained by an athlete that has qualified to the 2022 FIVB Beach Volleyball World Championships through FIVB Entry points as of 23<sup>rd</sup> May 2022.
  - The sum of all NF 2 finishes in all events the NF concerned participated will be the final ranking points of NF 2, regardless of the different players' composition of the team in each tournament, but not including result obtained by an athlete that has qualified to the 2022 FIVB Beach Volleyball World Championships through FIVB Entry points as of 23<sup>rd</sup> May 2022.
  - There will be maximum 2 ranks from the same NF per gender in the AVC Beach Tour National Federation Ranking. Accordingly, it is possible to have 2 ranks from the same NF per gender among the four (4) highest ranks in the AVC Qualification pathway.
  - In the case there is a tie in the AVC Beach Volleyball National Federation Ranking, the tie will be broken firstly by the best result obtained by the NF in 2021 Asian Beach Volleyball Championships; and there is still a tie, then the NF with best result obtained in 2020 Asian Beach Volleyball Championships ranks higher; and if there is still a tie, then the NF with highest points obtained from all tournaments above-mentioned in 4.1 will rank higher; and if there is still a tie, a drawing of lots will be conducted by the AVC to break the tie as the last resort.

# CAVB Qualification System To the 2022 FIVB Beach Volleyball World Championships

# 1. Max Total Quota from CAVB Qualification Pathway

- Men: 4 teams (8 athletes)
- Women: 4 teams (8 athletes)

# 2. Type of allocation of Quota places

The quota place is allocated to the National Federation (NF). Each NF must choose its athletes respecting the criteria set forth in 3. Athletes Eligibility.

# 3. Athlete Eligibility

All athletes must comply with the criteria set forth in the 2022 FIVB Beach Volleyball World Championships Qualification System document circulated on 28<sup>th</sup> February 2022.

Additional CAVB Eligibility Criteria:

To be eligible to represent a NF allocated a quota place through the CAVB qualification pathway to the 2022 FIVB Beach Volleyball World Championships, an athlete must have participated in at least one (1) of the homologated events listed in the qualification pathway listed in 4. Qualification Pathway as below.

#### 4. Qualification Pathway

- 4.1 CAVB Qualification period will be from the 1st of June 2019 until 30th of April 2022
- 4.2 The four (4) highest ranked National Federations per gender, based on the sum of points earned by each unique pair as a team in the four (4) events listed below in 4.3, will qualify to the 2022 FIVB Beach Volleyball World Championships, respecting the maximum number of quota places per NF per gender and the provisions established in the 2022 FIVB Beach Volleyball World Championships Qualification System document circulated on 28<sup>th</sup> February 2022.
- 4.3 The following four (4) events shall be used for the purposes of calculating the points to determine the ranking for each National Federation's unique pair.
  - 2019 Africa Beach Games, SAL- Cape Verde 19-23 June 2019.
  - 2019 African Games, Rabat Morocco 16-20 August 2019.
  - 2021 CAVB Continental Cup 2<sup>nd</sup> Round phase, Agadir Morocco 22-25 June 2021.
  - 2021 CAVB Continental Cup Final phase, Agadir Morocco 25-27 June 2021

# CEV Qualification System To the 2022 FIVB Beach Volleyball World Championships

# 1. Max Total Quota from CEV Qualification Pathway

- Men: 4 teams (8 athletes)
- Women: 4 teams (8 athletes)

#### 2. Type of allocation of Quota places

The quota place is allocated to the team. Each athlete of the team must meet the criteria set forth in 3. Athletes Eligibility.

#### 3. Athlete Eligibility

All athletes must comply with the criteria set forth in 2022 FIVB Beach Volleyball World Championships Qualification System document circulated on 28<sup>th</sup> February 2022.

There is no additional CEV eligibility criteria.

#### 4. Qualification Pathway

4.1 One (1) quota place per gender will be allocated to the Winning team of 2021 CEV Beach Volleyball European Championship/EuroBeachvolley held in the Vienna of Austria on 11<sup>th</sup> to 15<sup>th</sup> August 2021, i.e. Mol, A./Sørum, C. from Norway (Men) and Brunner/Huberli from the Switzerland (Women).

Should one or both of the above team(s) already have sufficient entry points among the top twenty-five (25) teams, as per 23<sup>rd</sup> May 2022, to qualify through FIVB Entry Points to the 2022 FIVB Beach Volleyball World Championships, the quota place(s) concerned will be reallocated to the next highest ranked eligible team(s) of the same gender from CEV not yet qualified, as per the FIVB Team Entry on 23<sup>rd</sup> May 2022, whose NF has not yet obtained the maximum quota places (i.e. four (4) for foreign NF and six (6) for host NF Italy).

- 4.2 Three (3) quota places per gender will be allocated to the next three (3) highest ranked eligible teams from CEV not yet qualified through FIVB Entry Points to the 2022 FIVB Beach Volleyball World Championships, as per 23<sup>rd</sup> May 2022, whose NF has not yet obtained the maximum quota places (i.e. four (4) for foreign NF and six (6) for host NF Italy).
- 4.3 Before the Drawing of lots for the Pool phase, in case there is change of player request for an athlete qualified from CEV qualification pathway, the new team shall have enough entry points, as of 23<sup>rd</sup> May 2022, to maintain its position. Otherwise, the team shall be placed in the reserve and the next highest ranked eligible team from CEV not yet qualified, as per 23<sup>rd</sup> May 2022, shall be picked up to fill roster, providing that their NF has

not yet obtained the maximum quota places (i.e. four (4) for foreign NF and six (6) for host NF Italy).

4.4 Before the Drawing of lots for the Pool phase, in case there is withdrawal request of a team qualified from CEV qualification pathway, the next highest ranked eligible team from CEV not yet qualified, as per the FIVB Team Entry points on 23<sup>rd</sup> May 2022, shall be picked up to fill roster, providing that their NF has not yet obtained the maximum quota places (i.e. four (4) for foreign NF and six (6) for host NF Italy).

# CSV Qualification System To the 2022 FIVB Beach Volleyball World Championships

# 1. Max Total Quota from CSV Qualification Pathway

- Men: 4 teams (8 athletes)
- Women: 4 teams (8 athletes)

# 2. Type of allocation of Quota places

The quota place is allocated to the National Federation (NF). Each NF must choose its athletes respecting the criteria set forth in 3. Athletes Eligibility.

Only one team per gender per NF will qualify as per the CSV ranking.

# 3. Athlete Eligibility

All athletes must comply with the criteria set forth in the 2022 FIVB Beach Volleyball World Championships Qualification System document circulated on 28<sup>th</sup> February 2022.

There is no additional CSV eligibility criteria.

#### 4. Qualification Pathway

- 4.1 CSV Qualification period will be the 2019/2022 and 2021/2022 season (until May 15<sup>th</sup> 2022), which started on 7<sup>th</sup> February 2020 until 15<sup>th</sup> May 2022.
- 4.2 The four (4) highest ranked National Federations per gender, based on the sum of 2019/2020 season and 2021/2022 season (until 15<sup>th</sup> May 2022) CSV Continental Tour National Federation Ranking, with the lowest ranking points during both seasons being discarded, will qualify to the 2022 FIVB Beach Volleyball World Championships, respecting the maximum number of quota places per NF per gender and the provisions established in the 2022 FIVB Beach Volleyball World Championships Qualification System document circulated on 28<sup>th</sup> February 2022 .

The CSV Continental Tour National Federation Rankings are based on the cumulative total of the CSV NF points earned at CSV Continental Tour events in a calendar year. CSV NF points are awarded to the highest finishing NF team at each CSV Beach Tour event.

# NORCECA Qualification System To the 2022 FIVB Beach Volleyball World Championships

# 1. Max Total Quota from NORCECA

- Men: 4 teams (8 athletes)
- Women: 4 teams (8 athletes)

# 2. Type of allocation of Quota places

The quota place is allocated to the National Federation (NF). Each NF must choose its athletes respecting the criteria set forth in 3. Athletes Eligibility.

# 3. Athlete Eligibility

All athletes must comply with the criteria set forth in 2022 FIVB Beach Volleyball World Championships Qualification System document circulated on 28<sup>th</sup> February 2022.

There is no additional NORCECA eligibility criteria.

#### 4. Qualification Pathway

- 4.1 The NORCECA Beach Volleyball Qualification Tournament to the 2022 FIVB Beach Volleyball World Championships, scheduled on 16<sup>th</sup> to 17<sup>th</sup> April 2022 in Dominican Republic in the cities of Macao and Santo Domingo will decide the four (4) quota places per gender from NORCECA qualification pathway.
- 4.2 Each National Federation is allowed to register one (1) team per gender to the abovementioned Qualification Tournament, and the registration is open to top twelve (12) National Federation as of NORCECA Beach Volleyball National Federation Ranking established for the period of 7<sup>th</sup> May 2019 to 1<sup>st</sup> March 2022. (Details refer to **Appendix 1**)
- 4.3 Two (2) Groups with six (6) teams each pool per gender will be organized respectively in the cities of Macao and Santo Domingo for the above-mentioned qualification tournament, following the serpentine system to place the 12 teams per gender to each pool. The top two (2) winners of each pool will be awarded the quota place to the 2022 FIVB Beach Volleyball World Championships through the NORCECA continental qualification pathway.
- 4.4 In the case that any National Federation declines its participation, the next eligible National Federation as per NORCECA Beach Volleyball National Federation Ranking (appendix 1) will be picked up.
- 4.5 Should the NF from the top two (2) of any pool of the Qualification Tournament obtain the full quota place (i.e. four (4)) through the FIVB Entry Ranking as of 23<sup>rd</sup> May 2022, such quota place from NORCECA Qualification Tournament will be reallocated to the next best ranked National Federation of the same pool in the above-mentioned qualification tournament.
- 4.6 Should one or more of the above qualified National Federations decide not to use the quota place obtained from the NORCECA qualification pathway to the 2022 FIVB Beach Volleyball World Championships, the quota place(s) will be then reallocated to the next best ranked eligible team/NF (i.e. 5th, 6th 7th and 8th, etc. as per the final ranking of the placement matches) at the above-mentioned tournament. After all above efforts are explored, upon consideration of NORCECA and upon approval of the FIVB, the other National Federation

qualified through NORCECA qualification pathway can use the quota place(s) until fulfilling the maximum quota place (i.e. four (4) per National Federation) if needed. In any case, NORCECA will use the entire quota place of 4 vacancies per gender.
