Please read carefully

1.1 Eligible Participants

1) Fully Vaccinated (two doses of vaccine, excepted Johnson & Johnson that only need one dose) against COVID-19 with a vaccine approved by Thai FDA/The Ministry of Health/WHO no less than 14 days before departure. Children under the age of 18 that are traveling with fully vaccinated parents/guardians are eligible without proof of Vaccination. Participants who have not been vaccinated, the ones without a vaccine certificate, or partially vaccinated must stay in quarantine of 10 days upon their arrival.

2) Must have health insurance with minimum coverage of 50,000 USD and cover COVID-19 treatment in Thailand throughout the entire duration of stay. 3) Must obtain payment proof for COVID-19 testing in Phuket via this link: <https://www.thailandpsas.com/>. All participants will be tested upon arrival at the Phuket International Airport.

1.2 Phuket Sandbox Guidelines and Procedure of Entering Phuket Sandbox

Phuket Sandbox [Phuket Sandbox | How to Apply | ThaiEmbassy.com](#)

The Phuket Sandbox is implemented by the Thailand government to allow fully vaccinated people to enter the island of Phuket and under required conditions to move freely in the island.

- 1) Travelers must be fully vaccinated against COVID-19 no less than 14 days before the travel date, with a vaccine registered with the Food and Drug Administration (FDA) of Thailand or approved by WHO or Thai Ministry of Health, and must possess a valid Vaccination Certificate/Card (digital or paper format)

The Accepted Vaccines are as follows ;

- AstraZeneca
- Moderna
- Johnson & Johnson
- Sinovac Biotech
- Sinopharm
- Serum Institute of India (SII)
- Pfizer - Biontech
- Heterologous Prime Boost
- Sputnik

- 2) Travelers need to have a Certificate of Entry. Thailand Volleyball Federation in collaboration with the Thailand Government will facilitate the application procedure and provide participants with such document. Please note that COE will be issued at least 3-7 working days after the Ministry of Foreign Affairs has received all documents from Organizer.
- 3) Travelers must do a COVID-19 test (RT-PCR method) with test result no more than 72 hours prior to the departure time. The negative result must be presented to the airline check-in counter.
- 4) All travelers must download ThailandPlus Application before travel to Phuket Sandbox.

Since 1st November 2021, Thai Government collaborate with the Ministry of Foreign Affairs to revised and declared for the new regulations for welcoming all travelers from every part in the world to travel to Thailand. However, Thailand Volleyball Association would like to inform that all participants are responsible for preparing documents and proceed to register in Thailand Pass website: <https://tp.consular.go.th> by themselves. After registered, you will receive the QR Code to present to Thai immigration. Thailand Volleyball Association will collaborate with the Sport Authorities of Thailand and the Ministry of Foreign Affairs to issue the visa exemption for all participants. To obtain visa exemption, all participants must send the following information to Thailand Volleyball Federation by **15 November 2021**.

- Passport copy for each participant (color copy)
- Flight ticket
- Vaccination Certificate (in English)
- COVID-19 health insurance covering medical and hospital expenses engaged up to 50,000 USD
- Proof of payment of Covid-19 testing while in the Sandbox via this link <https://www.thailandpsas.com/>.
- Confirmation of dates for which accommodation must be booked

6) RT-PCR Testing Package

All participants are required to book the PCR-Test package in <https://www.thailandpsas.com> by themselves. Please carefully keep the proof of payment and send it to the organizer at bvbwchs@gmail.com. Organizer will send the payment proof to the hotel accordingly. Athletes and FIVB officials must keep the receipt as upon submission of the payment receipt, organiser will reimburse them for such a cost. Athletes can bring the receipt to reimburse from TVA during preliminary inquiry.

Note: all participants are required to have the proof of payment for COVID-19 test

Please find below the latest update of "COVID-19 TESTING PACKAGE IN PHUKET" procedures during your stay in Phuket Sandbox;

1. All participants will be tested (PCR test) upon arrival at the Phuket International Airport. This testing is the package you booked from <https://www.thailandpsas.com/> (the cost 2,400 THB per time per person)
2. After you undergo the first PCR-Test, you will receive the ATK 1 set from the official, please keep it carefully in order to use for your second swab test (the second swab test by ATK will be required to do on day 6 for travellers who stays over 7 days)
3. In case you stay less than 7 days, you don't need to do the ATK.
4. All participants have to undergo an exit PCR-Test before your departure. Please make sure that you know the requirement and regulations of the country you are flying to and the airlines which you will use to leave Thailand to perform your test accordingly. It is the responsibility of each individual to inform the hotel reception about the above requirements to ensure that the test is booked in an appropriate time considering the necessary time required to deliver the COVID-19 PCR test result.

Cost of exit test must be paid directly at the reception when booking the test except athletes and FIVB officials as organizer will cover this cost. Once exit test is booked, hotel will do the necessary coordination with the Laguna Centre where tests will be conducted.

Athletes of the same team must wear the same colour and style of shorts. The display of the individual players' sponsors' logos on shorts and accessories must comply with the FIVB Sports Regulations and Handbook.

3. GENERAL MATTERS

3.1 Arrival and Departure

The official airport confirmed by the organizer is as follows:

Name of the airport: **Phuket International Airport**

Distance from the airport to venue: 21 km.

Organizer will provide the airport transfer for all participants.

Participants are required to arrive in Phuket airport directly. No domestic flights can be taken to Phuket unless you will be doing your 10 days quarantine (if not fully vaccinated) in Bangkok.

3.2 Board and Lodging

The organizers will provide the **Main Draw teams** with hotel accommodation (**double room**) in the Organizer's designated hotel and with meals from the evening before the start of the Main Draw until the day after the elimination of the teams from the event, breakfast included.

Athletes will be personally responsible for all extras at the hotel such as mini-bar, phone calls, laundry, etc. to be paid upon checkout.

For the qualification players, organiser will cover the cost of accommodation from 4 to 8 December 2021.
